Application together with company's profile, Supplier Registration Form and Photocopies of (i) business registration certificate (ii) certificate of incorporation (iii) local Authority permit and (iv) VAT certificate should be enclosed in a sealed envelope marked "Registration of Suppliers" and addressed to the Commissioner of Police, and deposited or sent by registered mail at the Registry of the Police Tender Unit, Police Department, Line Barracks, Port Louis on or before Friday 31 March 2017 at 13.30 hrs (local time).

Potential Suppliers/ Contractors/ Service Providers/ shall specify the field of his business.
Applicants are invited to take note of the following:

- (a) To submit list of items dealing with **(no price should be submitted at this stage)**.
- (b) The Police Department has no contractual obligations towards any applicant whomsoever.
- (c) This exercise shall not entitle applicant to be considered as exclusive Supplier /Contractor/ Service Provider of the Police Department
- (d) The Police Department reserves the right to proceed with tender proceedings at any time regardless of the outcome of this registration exercise.

Note: Compliant Suppliers, Contractors and Service Providers may be requested to submit original documents as and when required.
