Objective 4: Honing Investigation Techniques & Detection Skills Target 1:

Register at least 90% compliance with established protocols

Activities

* Conduct at least 6 training sessions on established Protocols for investigation of specific cases (e.g. Sexual abuses, Child Protection Act, Human Rights Protocols, etc...)

Target 2:

To record 20% detection rate in all reported cases

Activities

- * Achieve 95% detection rate in homicide cases.
- * Increase the detection rate of crime cases by 10%.
- * Increase the detection rate of Larceny cases by 5%.
- * Launch at least one intelligence driven operation on high profile targets.



Objective 5: Combating Trafficking & Use of Illegal Drugs

Target 1:

Achieve at least 75% success in drug related operations in terms of arrest and seizure

Activities:

- * Mount at least 2 intelligence driven operations per month in hot beds.
- * Conduct at least 6 training sessions for Southern Division personnel on drug investigation.



Target 2:

Ensure that 70% of places where drugs seized remain drugs free Activities:

Objective 1: Improving Quality of Life

Target 1:

Reduce larceny with aggravating circumstances by 2 %

Activities:

- Increase the number of stop and search operations in areas prone to property crimes by 15%.
- Increase the number of HCs checks by 20%.
- Double the number of Neighbourhood Watch Schemes in the Division.

Target 2:

Reduce the number of Road Accidents (K&SI) by at least 1%

Activities:

- Increase by 10 % the number of speed check operations along road accident prone axes.
- Conduct at least 2 operations monthly in the vicinity of licences premises to target drink driving.
- Increase by 10 % the number of awareness campaigns on Road Safety.

Target 3:

Increase the number of Community Policing Forum by 3%.

Activities:

* Increase by 3% the number of forums organised at neighbourhood level.

Objective 2: Enhancing Service Delivery

Target 1:

Mark at least 90% achievements on service standards set

Activities:

- Ensure that 90% of correspondences received are acknowledged within 48 hours.
- Ensure a reply to 90% of correspondences received within 15 days.

Target 2:

Resolve at least 90% of policing problems in consultation with stakeholders

Activities:

- * Conduct at least 1 forum per month with stakeholders to discus policing issues
- * Solve 90% of problem identified in Community Forums

Ensure 10% of Community Forums are carried out online

Activities:

- * Conduct at least 5 Community Virtual Forums monthly.
