LAUNCHING OF THE ERS TRANSPORT SQUAD



The Transport Squad (ERS-TS) which functions under the aegis of the Emergency Response Service (ERS) was set up to respond to the growing challenges in the Public Transport System. The primary aim of the squad is to prevent cases of larceny with violence/aggression against bus drivers/conductors and passengers, thereby ensuring a



safe Public Transport System. Another objective of the squad is to deterillegal taxi/van to operate and

other issues related to the safety and security of road users.

The squad is actually based at La Tour Koenig Police Station to cater for the increasing transport safety issues particularly in the regions of Pte aux Sables, Grand River North West, Albion, Stanley, Port Louis and Tombeau Bay.

Since its creation and full operational activities in April 2018, the Squad has effected 8 arrests, established over 850



contraventions and has conducted over 200 awareness sessions on safety and security with bus employees and passengers.

ACQUISITION OF NEW POLICE VEHICLES



In its continuous endeavour to enhance Police service to the community and in line with the objectives of the Commissioner of Police to better equip each and every Division/Branch/Unit of the Force, the MPF has acquired 136 new vehicles of different Make & Capacities. Since January 2018, 2 Microbuses, 4 minibuses, 10 cars, 52 Vans, 1 Lorry, 66 Motorcycles and a Recovery Truck have been acquired.

Most of these vehicles are dressed by the PRDU Graphic Team as per the battenberg pattern for distinguished high visibility and equipped with audible warnings which undoubtedly prove to be a deterrent to crime occurrence.



The majority of these vehicles have already been allocated to the different units of

the Force to improve their mobility and ensure a better service to the community.

In the same line Police will also receive delivery of 10 SUVs in August 2018 and 107 additional D/Cab Vans by October 2018. This will undoubtedly contribute to a Police which will be more visible, prompt service in our interventions thus adhering to Our Strategic Directions - Increasing Speed of Interventions.

TWO POLICE OFFICERS FOILED THE PLANS OF MISCREANTS ATTEMPTING TO BREAK INTO SHIBANI FINANCE PORT LOUIS



On Tuesday 12.06.2018 at 0315 hrs, crew of ERS Metropolitan (RM 4) composed of PC's 9862 Sookur and 3586 Luchmun received a phone call from OPS Room PL 'N' to attend a request at Shibani Finance at Corderie St, Port Louis where a larceny breaking is suspected.

On spot, the alarm was activated but there was no response from the watchman. The two Police Officers used their inquisitive skills and forced open the door of the building to locate

the watchman. The floor of the room was partially broken and a safe found thereat had its top



partially damaged and tools and equipment used to force access into the building were scattered.

They freed the watchman and whilst patrolling the vicinity, arrested a suspect. PC's 9862 Sookur and 3586 Luchmun successfully prevented a theft of a huge sum of money kept in a safe of the institution.

Subsequently, on Friday 15.06.2018 at the Police Headquarters, they were individually congratulated by the Commissioner of Police Mr. Karl Mario NOBIN, PMSM, for their commitment, alertness and courage displayed in the course of their duties.

SADC REGIONAL PILOT SHORT AND LONG TERM ELECTION OBSERVATION TRAINING



The Southern African Development Community (SADC) launched its pilot regional short and long term election observation training in Pretoria, South Africa from 1 to 12 May 2018. The curriculum is based on the region's electoral experiences and the revised SADC Principles and Guidelines Governing Democratic Elections.

The training presented a key milestone in the region's election observation training. The revised SADC Principles and Guidelines Governing Democratic Principles introduce the electoral cycle approach which involves the use of long term observation techniques by the SADC Electoral Observation Missions (SEOMs). The long term approach will enable SADC observers to have a more holistic approach for assessing pre-election, election and post-election periods of national elections held in SADC countries.

The training modules focused on the role of observers and covered a range of topics which included conflict analysis, assessing legal and constitutional frameworks; gender and electoral processes in the SADC region, report writing, and the use of information technology in election observation.

Two Police Officers from the Police Headquarters were privileged among the forty participants drawn from varied backgrounds, including experts in gender, security, conflict resolution, political and electoral affairs, as well as members of the SADC Electoral Advisory Council (SEAC), participated in the training.

BOODNAH P. V THE STATE, 2018 SCJ 91



HOW TO DISPROVE THE DEFENCE OF ALIBI?

There is no obligation upon the prosecution to show that the appellant could not have been at all the places he alleges he was. It is sufficient for the prosecution to establish that the appellant was at the scene of the crime at the material time.

In Boodnah v The State 2018 SCJ 91, the appellant, was convicted for the offence of making use of offensive words in a public place in breach of section 28(1)(f) and 2 of the Criminal Code (Supplementary) Act. He appealed against his conviction. One of the grounds of appeal was that "the Learned Magistrate erred in her conclusions that the prosecution has disproved the alibi of the Appellant".

It was held that it was rightly concluded that the prosecution had adduced sufficient evidence to disprove the alibi raised by the appellant. The following extract of the case of Foollee v The State [2004 SCJ 251], was quoted:

"...Whilst the burden of proof is always on the prosecution, it is clear that when evidence capable of proving the case against the accused and of disproving his defence is adduced by the prosecution, there is a kind of "tactical burden" which is borne by the accused in the sense that if he does not adduce evidence in rebuttal he may well find the case proved against him: in other words, the evidential burden shifts to the accused..."

In was held in the present case (Boodnah vThe State 2018 SCJ 91) that the evidence of Mrs S, the main witness for the prosecution, was analysed by the trial Court which found no contradictions in her testimony. Her version was found to be consistent throughout. The Court was convinced trustworthiness of Mrs S and had the privilege and benefit of seeing her deposing before it and subjected to a rigorous cross-examination by appellant's Counsel. Indeed the line of cross-examination of the appellant's Counsel showed that the appellant's presence at the locus at the material time was not challenged but was in fact accepted. Therefore, the learned Magistrate cannot be faulted for having accepted the evidence of Mrs S that the appellant was present at the site at the material time, had urinated and had used filthy words in public in front of her and her children. After having pitted the oral evidence of Mrs S the appellant's unsworn version against contained in his out-of-court statement, the trial Court had satisfied itself of the plausibility of Mrs S's version that she had not fabricated the whole story against the appellant, and was perfectly entitled to conclude that the prosecution had disproved the alibi raised by the appellant in his out-of-court statement.

As stated in Mooniaruch v The State [2010 SCJ 21] cited in The Director of Public Prosecutions v Camoin [2011 SCJ 129], "It is trite law that, once an alibi is raised, it is for the prosecution to rebut that alibi... However, there was no obligation upon the prosecution to show that the appellant could not have been at all the places he alleged he was. It was sufficient for the prosecution to establish that the appellant was at the scene of the crime at the material time."

The following extract from Babeea v The State [1997 SCJ 239] is also cited in Boodnah v The State 2018 SCJ 91: "in accepting the version of the complainant, the learned Magistrate was indirectly rejecting the version of the Appellant that at the material time he was at his place and not at the site. As the learned Magistrate did not misdirect herself as to the burden of disproving the alibi, we find no cause to intervene."
