FLOODING INTERVENTIONS BY SMF/ DRU



Our island witnessed the terrible effects of heavy rainfall on Tuesday 09th and Wednesday 10th of April 2019 in the vulnerable regions of the north and Port Louis. The villages of Cottage, Fond du Sac and Poudre d'Or Hamlet witnessed the wrath of Mother Nature. The SMF, including the Disaster Response Unit (DRU) had multiple teams pre-positioned before, during and after the flooding. The various tasks of the DRU and other elements of the SMF consisted of evacuation of families from flooded houses, water pumping, removal obstruction, re-assuring the local communities and post disaster cleaning operations. At Fond du Sac, our teams

evacuated nine families, most of which were the elderly and disabled.

Similarly, at Cottage, two families were evacuated, including children. Some other tasks were carried out successfully by our teams comprised of removal of obstructions from main access roads and rivers, as well as the felling of trees.



The SMF and DRU leave no stone unturned in Disaster Management and are committed to ensure the safety of our inhabitants.

HUMAN TRAFFICKING



Human Trafficking is global phenomenon and Mauritius is not immune from it. With a view to combatting such illegal acts, Combatting in Trafficking in Persons Act was enacted in Mauritius in year 2009. Since then, the Police have been enforcing the provisions thereof.

In our law, to establish a case of trafficking in persons, the following acts are essential to be present in line with the constitutive elements:

"exploitation", which includes -

- (a) all forms of slavery or practices similar to slavery, including forced marriage;
- (b) sexual exploitation;
- (c) forced labour; and
- (d) the illegal removal of body organs;

"forced labour" means labour or services obtained or maintained through threats, the use of force, intimidation or other forms of coercion, or physical restraint;

"sexual exploitation" means obtaining financial or other benefits through the involvement of another person in prostitution or in other kinds of sexual services, including pornographic acts or the production of pornographic materials, as a result of subjecting another

person to one of the means listed in paragraph (a) of the definition of "trafficking";

"slavery" means the exercise of any or all of the powers attaching to the right of ownership over a person;

However when establishing the case, we must know the definition of "Trafficking". Our legislation has made provision for the definition which is as follows:

"trafficking" means -

(a) the recruitment, sale, supply, procurement, capture, removal, transportation,

transfer, harbouring or receipt of a person

(i) by the use of threat, force, intimidation, coercion, abduction, fraud, deception, abuse of power or abuse of a position of vulnerability; or

(ii)by the giving or receiving of payments or benefits to obtain the consent of a person having control or authority over another person; or

(b) the adoption of a person facilitated or secured through illegal means, for the purpose of exploitation;

The Trafficking Protocol clarifies that trafficking in persons has three constituent elements:

- (1) An act (what is done);
- (2) The means (how it is

done); and

(3) Exploitative purpose (why it is done).

Essential Elements of Trafficking in Persons

• Recruitment
• Transportation
• Transfer
• Harbouring
• Receipt

Threat/Use of force

- Other forms of coercion
- Abduction
- Fraud
- Deception
- Abuse of Power or of position of vulnerability
- Giving or receiving of payments or benefits to achieve the consent of a person having control over abother person
- Exploitation, including prostitution of others or other forms of sexual exploitation
- Commercial Sexual exploitation of children
- · Forced labour or services
- Slavery or pratices similar to slavery
- Servitude
- · Removal of (body) organs

CUTLASS EXPRESS EXERCISE 2019 PARTICIPATION OF CGS BARRACUDA - PEMBA. **MOZAMBIQUE**



Barracuda under the helm Commander Kunal Bharadwaj participated for the first time in a multinational training exercise 'CUTLASS EXPRESS 2019' held from 27 January to 08 February 2019 in Pemba, Mozambique. The aim of the exercise is to improve law enforcement capacity, promote regional security and progress interoperability between the armed forces to combat illegal maritime activities in the Western Indian Ocean.

Personnel of armed forces from the East African countries participated in the Exercise and were trained by instructors from the United States Navy and Coast Guard jointly with the collaboration of tutors from the International Maritime Organisation (IMO), Combined Maritime Force (CMF) and European Naval Forces (EUNAFOR).

The presence of CGS Barracuda at Pemba, Mozambique played a vital role for planning,



co-ordination and execution. The ship had acted as an afloat platform for the conduct of Visit Board Search Seizure (VBSS)

Exercise for participating nations comprising of Mozambican, Malagasy, Tanzanian, French Navies and NCG Marcos. The various scenarios enacted during the VBSS included IUU Fishing, Drug and Weapons trafficking.

Sailing from Mauritius to Mozambique by CGS Baracuda has proved the extended endurance of the ship as a favourable platform to undertake extensive maritime borne operations, surveillance mission and Anti-piracy operations. The ship's transit in High Piracy Zones off the Eastern Coast of Africa has enhanced the ship's crew reaction and capabilities for intervention in case of any attack.




Services) is aimed empowering at them on anticorruption policies and related issues so that they stand guided by the principles of integrity and responsibility
