# Regulations made by the Minister under section 48(2)(b) of the Firearms Act

- 1. These regulations may be cited as the Firearms (Amendment of Schedule) Regulations 2020.
- In these regulations –"Act" means the Firearms Act.
- 3. The Second Schedule to the principal Act is repealed and replaced by the Second Schedule set out in the Schedule to these regulations.
- 4. These regulations shall come into operation on 1 January 2021.

# Regulations made by the Minister under section 48 of the Firearms Act

- 1. These regulations may be cited as the Firearms (Competency Certificate) (Amendment) Regulations 2020.
- 2. In these regulations —

"principal regulations" means the Firearms (Competency Certificate) Regulations 2007.

- 3. Regulation 10 of the principal regulations is revoked and replaced by the following regulation
  - 10. Where the Commissioner is satisfied that a competency certificate is lost or destroyed during its validity period, he may, on application by the licensee, issue a duplicate competency certificate subject to the payment of the appropriate fee specified in Third Schedule.
- 4. The Third Schedule to the principal regulations is revoked and replaced by the Third Schedule set out in the Schedule to these regulations.
- 5. These regulations shall come into operation on 1 January 2021.
