A certificate of competency to drive were granted to those who could show proficiency in repairing and replacing tyres and some knowledge on the Motor Regulations. As from August 1921, the Traffic Branch was responsible to examine and register motor drivers as well as examination of vehicles. The First Road Traffic Code was published in year 1931.

# Traffic Branch ANNUAL OPERATIONAL PLAN 2021



## Foreword

am pleased to present the Annual Operational Policing Plan for Traffic Branch for the year 2021.

The trend of Road Accidents in Mauritius is very dynamic. The increasing vulnerability of road users to road traffic accidents is mainly due to speeding, drink driving, careless driving and heedless crossing of the road. Our analysis revealed that pedestrians and riders are the largest victim group of fatalities and injuries. The management of road accident is based on the concept of 4E's; Engineering, Enforcement, Education and Evaluation. The Traffic Branch is mostly involved with Enforcement, Education and Evaluation.

During the year 2020, the Traffic Branch spared no effort in the enforcement of Road Traffic laws throughout the island to detect and deter infractions of traffic laws. The quantity and quality of enforcement against road safety related offences was

considerably enhanced and operations carried out were intelligenceled and targeted.

Along with the enforcement programme, the Traffic Branch is also very much involved in the sensitisation and education of drivers and other categories of road users to promote safe driving and safe behaviours on our roads. In order to bring the road accident to a downward trend and to render our roads safer, the Traffic Branch will maintain concerted efforts in partnership with Police Divisions and other units of the Force both on enforcement and education campaigns.

This plan paves our way towards improving safety and security of our roads and rail and our strategic objectives in better policing our roads.

#### REDUCING ROAD ACCIDENTS

(i) To reduce the number of Road Accidents (K&SI) by 3%

K&SI Accidents refer to cases where one or more persons involved therein have been Killed or Seriously Injured We endeavour to check on the behavioural problem which leads to the occurrence of such accidents. We aim at further reducing road accidents by performing more intelligence-led speed checks. alcotests operations and establish road-safety related contraventions at accident-prone areas.

- (i) Ensure 75% of correspondences/ letters are responded to within 21 days.
- (ii) Reply to PHQ's within 15 days as the case may be.
- (iii) Reply to PIAC correspondences within five (5) working days.
- (iv) Ensure a 100% usage of Crime Occurrence Tracking System (COTS).

Administrative mechanisms in place at the level of Traffic Branch play a vital role and has a direct impact on Policing and the quality of service delivery. Therefore, we will ensure that administrative support are optimised in ensuring that objectives set are achieved.

#### **PUBLIC SENSITISATIONS**

(i) To Increase our Sensitization Campaign by 3 %

We aim to increase awareness session on road & rail safety to educate road users on road safety precautions as well as to keep the public abreast of the existing road traffic legislations and amendments thereto. Moreover the public is being sensitised on the importance of the use of seat belts through the Roll-Over Simulator. Road safety education is of paramount importance and essential element to ensure good road safety behaviour. We intend to further increase the number of sensitization campaigns by 3%.

#### **ENHANCING SECURITY ON PUBLIC ROAD & RAIL**

- (i) Conducting targeted operations daily (Seat belt, Using Cellular Phone, Failing to comply with traffic lights);
- (ii) Carrying out Alcotest & Speed Check Operations twice daily;
- (iii) Conducting monthly sensitization campaign on Road Safety with members of public, road users, etc.;
- (iv) Conduct guarterly meeting with stakeholders, Driving School Operators, etc...)
- (v) Preventing illegal Parking by conducting Wheel Clamp Operations island-wide.

**IMPROVING ONLINE SERVICE** COUNTER

(i) To Increase the processing of the number of applications at the Online Service Counter by 50 % with a view to reduce the waiting time to obtain a provisional driving licence.

The Online service counter of the Licensing office attends to an average 80 applicants daily. This service, which was limited to the application for provisional driving licences for auto/motorcycle and private cars, has been extended to all categories of vehicles. With a view to improve our quality of service by enabling processing of such

applications on a reasonable time delay; we intend to increase the processing of the number of applications daily by 50% (from 80 to 120 daily).

(i) To Increase our Intelligenceled Operations by 5 %.

**ROAD SAFETY** 

**OPERATIONS** 

With a view to curb down the non compliance to Road Traffic legislations, we will, on a daily basis, maintain dedicated operations targeting specific breaches such as speeding, drink and driving, use of mobile phone and failing to fasten seat belt. With a view to rendering our road safer, we will increase intelligence-led operations by 3 %.
